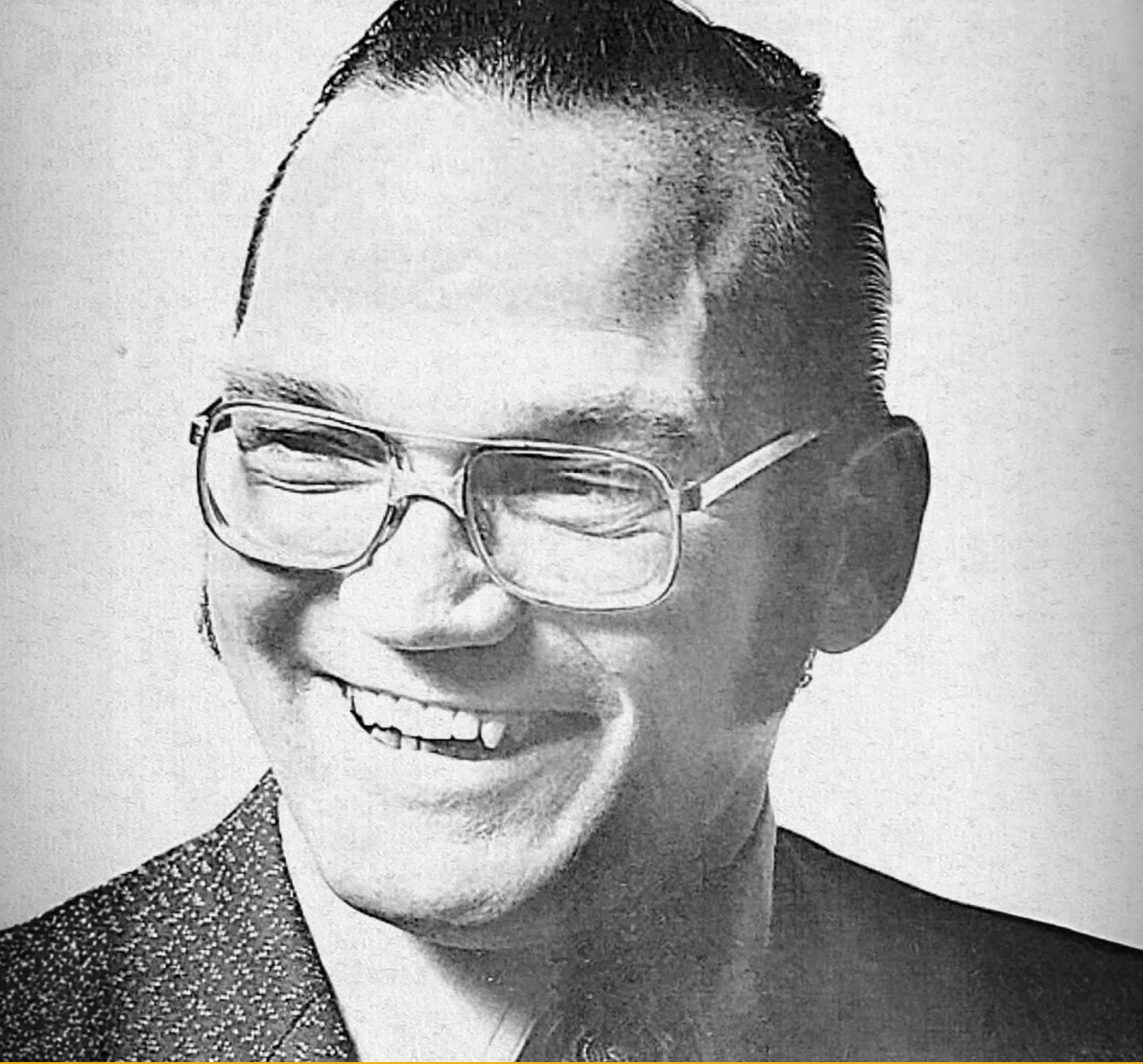


## Mission

Providing assistance to children experiencing nutrition insecurity is crucial for their growth, development, and overall well-being. ## Community Spirit: Newlife Community Church

Newlife Community Church in Pomona, situated along historic U.S. Route 66, upholds a tradition of aiding people in their community through their weekly food distribution, impacting hundreds of families weekly. With the pandemic exacerbating economic hardships, Newlife saw a surge in demand, from serving 800 to 1,600 families per week. Individuals like Joed Torres, once food insecure, now volunteer, embodying the ethos of giving back. Newlife's outreach extends to multigenerational families and provides essential support amidst rising inflation. Your support ensures vital assistance reaches those most vulnerable in our community.



## The Los Angeles Regional Food Bank's Mobile Food Pantry

The Los Angeles Regional Food Bank's Mobile Food Pantry (MFP) directly addresses food insecurity by bringing nutritious food to underserved communities and populations, including those in food deserts and on college campuses.

During the COVID-19 pandemic, many MFP distributions were converted into large-scale drive-through distributions, which were featured regularly in national and local news, making the images of long lines of cars and food going into trunks a central image of pandemic relief.

Today MFP, walk-up and drive-through distributions are ongoing and are essential in the fight against hunger.





# City of Industry Update

## The Food Bank's New Distribution Center

The LA Regional Food Bank's Distribution Center in the City of Industry represents a significant step forward in the fight against hunger in Los Angeles County. Thanks to strong donor support, renovations are underway to expand programs and increase capacity, with a notable increase in food distribution from 80 million pounds in 2019 to 115 million pounds in 2023. Key milestones include the completion of the refrigerator and freezer area, volunteer engagement center, and food rescue center, ensuring efficient operations and resource utilization. 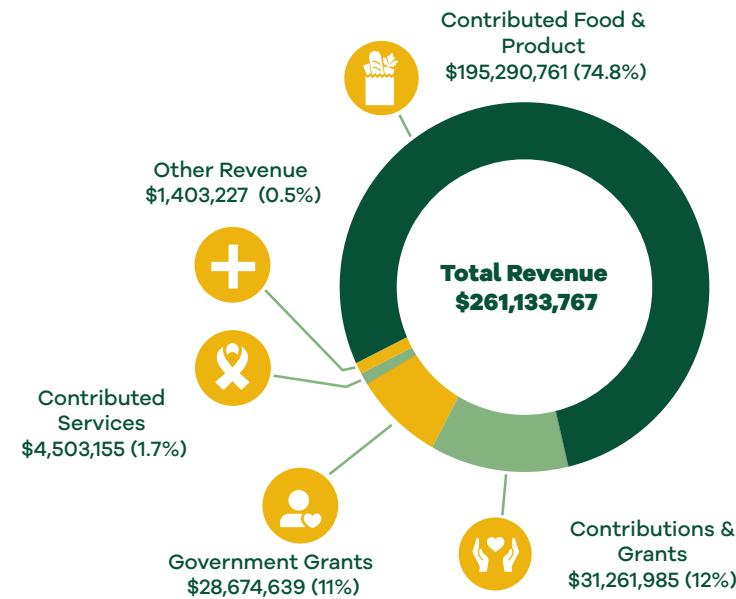

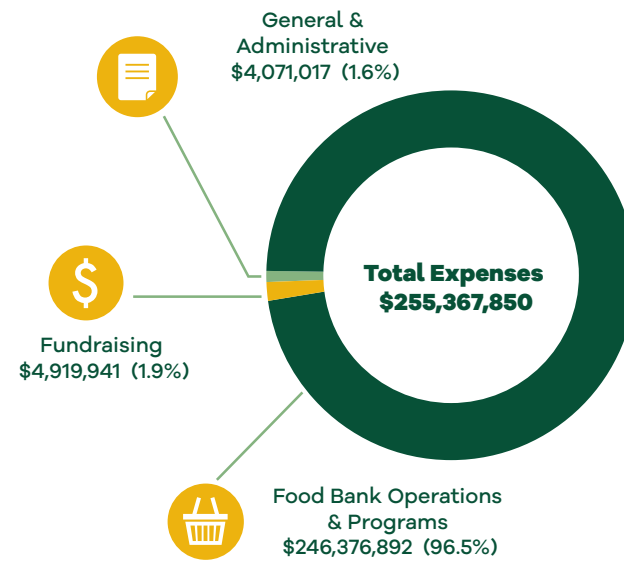

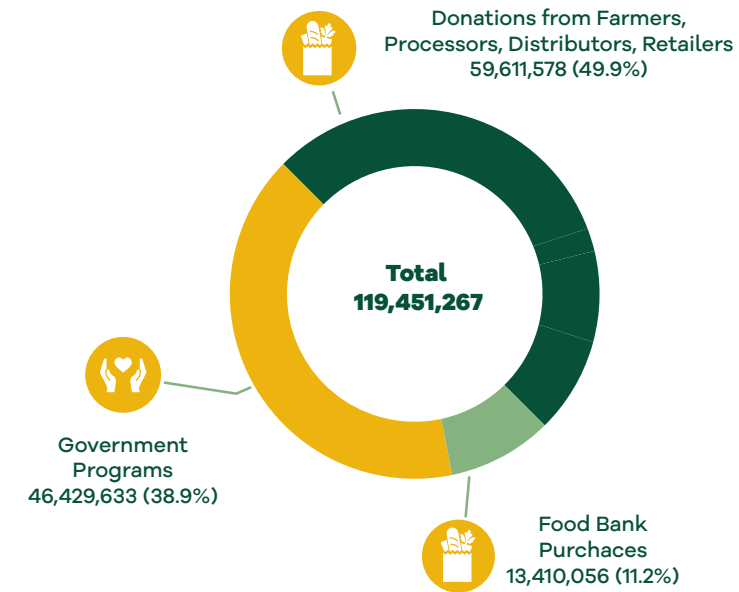
## 2023 WHERE OUR FOOD COMES FROM \$ 261,133,767



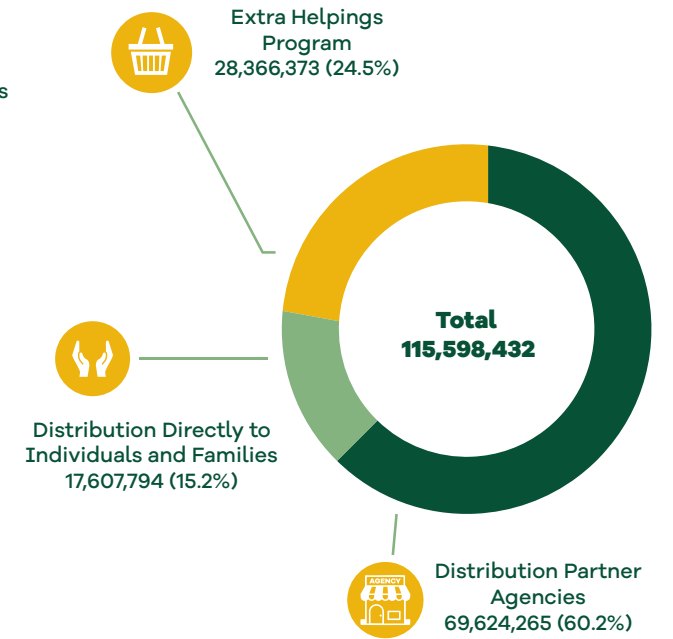
## 2023 TOTAL EXPENSES \$ 255,367,850
